**D. Approval of Meeting Minutes:** August 5th & August 25th, 202. Amy made a motion to approve the meeting minutes of August 5th and August 25th 2021, seconded by Yianni and Elisa, motion carried.

**E. Director's Report**: Hillary Miller: New public Health order that went into effect last week. Main changes are all students and all staff will be fully masked at all times, except when in the lunchroom actively eating. Onsite testing next week, unvaccinated staff will be tested 2x a week. Students can be tested with parent permission, Heather sent out an email last week with information about this. . Also staff who would like to be voluntarily tested can also sign up. Elisa: what is the format of the testing, saliva, or what? Hillary yes we are doing saliva testing for students and nasal testing for adults. Elisa: Is this only for students and staff? Hillary Correct. What is the turnaround for results? Hillary: They say a couple days we will see. What is the name of the program we are using and are there any incentives for students or the school? Hillary: Covid Check is what we will be using, I am unaware of any incentives. Looking into getting funding in place to cover Susans hours. There may be grant money out there and I am looking into it. Liz: I know that when you go to the district website to sign up for covid testing they are using incentives. Elisa: one of the county commissioners had mentioned a test and thats where I first saw incentives being offered. Hillar: Susan has been working from the county from the beginning so I am sure we are in line to whatever the district is doing.

Playground: Wood chips were supposed to be delivered yesterday, but the truck was too big, they are doing something different tomorrow. I am hopeful it wont impact recess to much. Basketball materials will be her next week! A to Z recreation said the process will be pretty quick.

I was asked by the district to provided a final approval on how the money was spent. I put in the email what we discussed at the last meeting. Elisa: I saw a public comment about the kitchen and vote for the bond but that is the last thing on our list. Hillary: I met with Karen and Shadow, and we have talked extensively about what could happen at GCS, it didnt sound very promising that we would have a full working kitchen. (need to listen at this point) 1 roof 2. Siding 3. Concrete in courtyard 4. Carpets replaced 5. Kitchen Yianni: has there been some sort of collaboration with the district and do we have a real quote? No, that has not happened yet. We have not priced anything out because we don't know if the bond will be approved. We need to think about what will be best for GCS. The board is all in agreement on the order of items listed above for the bond.

**F. Old Business** 1. 4 day week survey: the BOD will run this. Thank you staff for getting us your input. We will discuss this at the town hall meeting. We will run the survey for 4 day school week next week. We want to know what the plan is for GCS.
